- Resolved issue where sudo mtr sudo plugin prevents the binary from running.
- Resolved issue in which installing the 2.0 SR1 iC3 adapter caused a message on line 152 of the install.sh regarding lack of directory /../../paths.sh.
- Resolved issue where steam.app fails certificate validation and rule does not match.
- Resolved issue where com.apple.ServiceManagement.daemons.modify is not correctly restored on uninstall.
- Resolved issue where Unity mode was not usable with VMWare Fusion 11 and Privilege Management.
- Resolved issue where lpadmin fails to complete when run with sudo as root.
- Resolved issue where no event is raised on the endpoint for no license being present.
- · Resolved issue where TextEditLimitedTest tests sometimes fail.
- Resolved issue where User name in Auth Request Message boxes change to UNIX Username with Privilege Management installed.
- Resolved issue where dppolicyplugin could cause SecurityAgent to crash.
- Resolved issue where Chrome hangs when launched on 10.12 Mac with Privilege Management for Mac client installed.
- Resolved issue where Challenge Response Generator has a CFBundleldentifier of com.yourcompany.ResponseGenerator.
- Resolved issue with Licensing testing failure.
- Resolved an issue where the Privilege Management workspace doesn't load correctly.
- Resolved an issue where Privilege Management build scripts don't report what build scripts are run.
- Resolved issue where BIAdapter does not download policy when already existing one has been deleted.
- Resolved an issue in PGLib policy evaluation, in which valid xml exists, but invalid policy XML passed to Privilege Management for Mac caused Privilege Management for Mac to crash.
- Resolved an issue where BIAdapter Settings were not removed when uninstall script with -s arg ran.
- · Resolved an issue with BIAdapter, in which BI Policy permissions were being set incorrectly.
- Resolved an issue with Bi Adapter crashing when it cannot find the /Library/Application Support/Avecto/BIAudit folder.

- Resolved an issue where a license is valid but logged as an Error message.
- Resolved an issue where Privilege Management rules were evaluated last when taking control of com.apple.ServiceManagement.daemons.modify.
